The Term will automatically extend for further subsequent 12 month periods, unless: <ul style="list-style-type: none">• either Party provides written notice of termination at least 30 days prior to the end of the then Term; or• the Agreement is otherwise terminated in accordance with its terms.
<i>Go Live Date</i>	The sooner of: <ul style="list-style-type: none">• the date that the Development Services are available for your live or commercial use, as notified by us; or• the date of the first Training Session (if applicable).
<i>Services</i>	The services that we perform under this Agreement, out of: <ol style="list-style-type: none">1. Development;2. Bizazz Services;3. Managed Hosting & Support;4. Training; as specified in this Schedule and subject to any agreed Additional Services or Project Variations.
